

CRITERIA AND PROCEDURES (June 20, 1998)
FOR THE J. N. WORDLAW SCHOLARSHIP

1. The applicant must be a member of this church for a period no less than six (6) months before the filing of an application.
2. The applicant must be a graduate of an accredited high school, or have been previously admitted to the college or university, before the application is submitted.
3. The applicant must be recommended by a Church Officer or member.
4. The applicant must have maintained a "C" average or better in high school.
5. The applicant must have given evidence of being a "genuine Christian, and be in possession of a vital interest in the advancement of the Kingdom of God".
6. The applicant must complete and submit to the Scholarship Committee an application for the scholarship, no later than thirty (30) days preceding the commencement of the school year, or unit of attendance.
7. The school of enrollment must be an accredited institution of higher learning which shall yield an Associate of Arts Degree or a Bacheloriante Degree upon completion of matriculation.
8. The applicant must be enrolled as a full time student as defined by the institution of enrollment, as evidenced by an acceptable letter of good standing from the institution.
9. The applicant must continue to attend and serve Mt. Hebron for so long as the applicant receives the award, consistent with availability, proximity, school and work schedules.

CRITERIA FOR EDUCATIONAL ENCOURAGEMENT

The Scholarship Committee also encourages achievement at other levels of educational attainment. The church's recognition of these achievements is exemplified by presentation of acknowledgments in the presence of the entire church, preferably at the principal service. This time placement is to demonstrate that these acknowledgments and encouragements come from the entire church. They are:

1. Graduation from elementary school - Teen Bible
2. Graduation from High School - Student Study Bible
3. Graduation from College - Black Heritage, Woman's or Men's Bible.

SCHOLARSHIP COMMITTEE PROCEDURAL RULES
(June 20, 1998)

1. The Scholarship Committee shall make the awards of scholarships.
2. The decision of the majority of the committee is binding. Decisions of the committee must be rendered no later than September 15, and February 15 of each year.
3. To be eligible to vote on the award of scholarships, you must have been a member of the committee, for a period not less than six (6) months.
4. The committee shall consider the written input of significant contributors to the fund, the Deacon Board, the Trustee Board, and the Pastor. (Written input is required in order that there be no appearance of impropriety or favoritism. A record must also be kept to establish the basis of all committee decisions.)
5. The scholarships are awarded in step sequence. They are:
 1. First year student \$250.00 per year
 2. Second year student \$350.00 per year
 3. Third year student \$450.00 per year
 4. Forth year student \$650.00 per year

In the event that insufficient funds have been provided to the Scholarship Fund to distribute pursuant to this pattern, percentage and aliquotal reductions will be made to provide a reasonably proportionate result.
